Summary of Contents of Records Disclosed on April 26, 2024 by RCMP in response to Democracy Watch's July 2022 Access to Information Act request for all records of the investigation into alleged obstruction of justice by the Trudeau Cabinet by pressuring the Attorney General to intervene and stop the prosecution of SNC-Lavalin

Below is a summary of the contents of the single PDF sent from the RCMP to Democracy Watch by mail on April 26, 2024, with highlights about key information, developments or time periods during the investigation (<u>Click here to</u> <u>see</u> the PDF of the 1,832 pages total disclosed). 	Mentions that JWR talked with former Attorney Generals in fall 2018 at suggestion of Butts about granting a DPA to SNC- Lavalin, but that the section 13 document prepared by the Director of Public Prosecutions (DPP) and the Public Prosecution Service of Canada (PPSC) had convinced JWR that a DPA was not warranted and so she had already decided not to override the DPP (pp. 382-383).

On pages, 473-474, parts are redacted from Prince's description of the phone call she received on Sept. 16, 2018 from Mathieu Bouchard ("Bouchard") and Elder Marques ("Marques"), both then-Senior Advisor to the PM.
On p. 478, parts are redacted from Prince's description of the phone call she received on Sept. 16, 2018 from Ben Chin, then-Chief of Staff for then-Minister of Finance Bill Morneau.
On p. 483-484, Prince tells RCMP that during her Oct. 26, 2018 phone call with Bouchard he told her that JWR needed to intervene to help the Liberals get re-elected, and she clearly told him that JWR intervening would be political interference in a prosecution.
On pp. 487-488, parts are redacted from Prince's description of her meeting on Dec. 18, 2018 with Katie Telford, Chief of Staff for the PM ("Telford") and Gerald Butts, then-Principal Secretary to the PM ("Butts") at which she clearly told them that JWR was not going to stop the prosecution.
On p. 498, parts are redacted from Prince's answer. Again, no reason is given for any of these redactions.
On pp. 503-504, Prince discusses how the government would use retired Supreme Court Justices or other "eminent Canadian" to justify any of the government's actions that were difficult because the opposition parties couldn't "possibly impugn their credentials".
On p. 519, part is redacted from Prince's description of her notes concerning JWR's call on October 14, 2018 from then- Treasury Board Minister Scott Brison pressuring JWR to intervene in the prosecution of SNC-Lavalin.
On p. 523, Prince discusses SNC-Lavalin's court action to try to overturn the Director of the PPSC's decision to prosecute, and how the Department of Justice had to ensure that the PPSC had adequate counsel to defend the decision, as she and others had "been in private practice and we knew that you could throw money at stuff and sometimes you could take advantage of government lawyers."
On p. 525, Prince discusses the debrief JWR gave her of her meeting on Dec. 5, 2018 with Butts, and that JWR told her that she said to Butts re: the ongoing pressuring to intervene and stop the prosecution of SNC-Lavalin that "They have to stop doing this and I made it clear that they have to stop."
On pp. 526-528 and p. 532 Prince's describes her meeting on Dec. 18, 2018 she had with Telford and Butts, and how

	she told them that JWR intervening would be unconstitutional interference in a prosecution. Parts of her statement are retracted on p. 527 and another part on p. 528 and another part on p. 532.
	On p. 529, Prince states that JWR's "mind had been made up in September, and that was super clear to me and should've been super clear to everyone else" that JWR was not going to intervene to stop the prosecution.
